The former Kathryn Barzynski was born Nov. 20, 1886, at Chicago, daughter of the late John and Virginia Wilkowszewski Barzynski. She attended parochial schools at Chicago and Northside High School, Manitowoc, when the family moved to the city in 1901. She returned to Chicago in 1905 and attended Chicago Art Institute and Chicago College of Music.

She was married to H. F. Kelley June 23, 1915, at Sacred Heart Church and the couple made its home at 717 N. Seventh St. Mrs. Kelley was a member of Sacred Heart Church Rosary Society. Her husband, an attorney and former Manitowoc postmaster, died in 1951.
